Ripping apart the current ward structure will see Caithness, Sutherland and rural Ross-shire lose seats on the already Inverness-heavy Council. With the whole County of Sutherland absorbed into one local authority ward!

I have helped lead the campaign to stop these plans, working cross-party in the Highland Chamber to give remote and rural Highland a voice against the Commission.

It is deeply unfair that whilst the Islands have been protected from centralised democracy by the Scottish Government, rural Highland continues to be hit by plans to concentrate power in our large cities.

# ACTION NEEDED ON WINDFARM PAYMENTS

Due to the National Grid being unable to cope with the increasing renewable power production across the Far North of Scotland, the scandalous policy of constraint payments for windfarms continues.

Last year, windfarms in the County of Sutherland alone received over £63.5million NOT to operate. A figure larger than the combined constraint payments for the whole of England and Wales for the same year.

It is clear the energy policy at both Holyrood and Westminster is broken and I am calling for a reform of the practice and an immediate review of our National Grid system supporting local suppliers.

It is unacceptable that when thousands across Highland are living with fuel poverty, foreign multinational companies are being paid when their wind turbines aren't turning!

This September I visited the Port of Nigg as part of a scheduled visit with fellow Highland Councillors.

After being given a tour of the facility, it was concerning to hear that despite the billions being invested into both onshore and off-shore renewables, very little work is being sent to yards like Nigg. Although many elements of the wind turbines and their platforms can be made far cheaper overseas, the skills and experience built up over decades in Easter Ross should be perfectly placed to make the area a global leader.

That is why I am backing the UK Government's Free Ports initiative for Cromarty. An exciting opportunity to make Easter Ross a global gateway for the UK and incentivize businesses to invest money in the area.

# MY FIGHT AGAINST FUNERAL POVERTY

When I was elected three years ago I made a promise that I would do everything I could to help end the scandal that is funeral poverty. I am deeply disappointed that the Highland Council continues make no progress on the matter, particularly at a time of such national hardship due to the Coronavirus.

In June this year, I wrote to Scottish Government Ministers demanding them to act if the Highland Council would not. We cannot accept a postcode lottery when it comes to burying our loved ones and I will do everything that I can to keep fighting until this disgraceful practice is 'made right'.

# RETURN OF THE CAITHNESS PROVOSTS IS A CAMPAIGN PROMISE DELIVERED

When I campaigned to become a Councillor for the Thurso and Northwest Caithness ward, I put forward decentralisation and localism as my priority policies.

Last month, I delivered on this promise, with the County of Caithness regaining it's Provost roles. This reverses a decades-long decision when district Councils were abolished and the Highland Regional Authority was established in Inverness.

I am incredibly proud to have proposed this change and to have delivered directly elected Provosts back to the county. I am also blessed and humbled to accept the nomination as the Provost of Thurso for the remainder of the Council term.
